#### 6. To Consider a Request for a Donation to the New Inn Salvation Squad

Cllr Miss A Birch declared an interest in this item, and abstained from voting. Cllr Miss Birch reported to the Council the progress that had been made by the New Inn Salvation Squad and explained how a donation from the Parish Council would be spent. The Clerk conveyed information she had obtained from the Warwickshire Association of Local Councils (WALC) regarding donations to community groups of this nature. Following discussion, it was unanimously agreed that £500 would be donated under Section 137 of the Local Government Act 1972, and that a further £2,000 would be made available as an interest free loan. It was also agreed that the terms of the loan would be decided at the NLPC meeting to be held on 13 September 2016 once the Clerk had sought further clarification from WALC regarding the loan.

7.1 To consider planning applications received:

 $\underline{\text{Horsley House Farm}}, \text{ Norton Curlieu Lane W/16/1401HR} - \text{following discussion it was agreed that NLPC was neutral on this application, and had no comments or objections.}$ 

<u>The Barn</u>, Big House Farm, Church Road W/16/1308 - following discussion it was agreed that NLPC was neutral on this application, and had no comments or objections.

<u>The Garden House</u>, Wolverton Road W/16/1198 – following discussion it was agreed that whilst Norton Lindsey Parish Council has no objections to the actual extension to the existing property, it is very concerned with the proposed garage. There is very little information available for the garage and no plans indicating size, etc. NLPC is also concerned that the proposed garage will have an impact on the street scene in what is a prominent position in the village. There are also concerns that the building of a garage where indicated will cause damage to the existing trees.
