# 1. Chairman's notice regarding the recording and filming of the meeting

# 4. Declaration of interest (existence and nature) on items on the agenda

Cllr M Neale and Cllr R Mann declared interest in item 13.5 as members of the Cricket Club.

#### 5. Public comments

A member of the public raised continuing concerns regarding speeding traffic on Curlieu Lane, and discussion took place regarding the proposed planning application in Stratford District (item 14.2).

# 6. To approve the Minutes of the Ordinary Meeting held on 6 December 2016

#### 8. Matters arising

The Clerk confirmed that the WDC Head of Development Services had agreed to attend the February meeting to discuss the planning process, and she advised that if the Councillors had any specific questions these should be forwarded to WDC in advance of the meeting.

<u>Community Speedwatch Programme</u> – nothing new to report. WDC Cllr Rhead suggested that a letter should be written to the PCC advising the difficulty in setting up training, as this issue is one that the commissioner feels strongly about

<u>Traffic Calming</u> – nothing new to report. WDC Cllr Rhead advised that speeding in rural parishes was a concern to other parish councils, and suggested that a joint letter with other parishes to WCC and PCC expressing concerns about traffic calming and speeding would be useful.

<u>Dog bins</u> – The Clerk advised she was still awaiting a response from WDC. WDC Cllr Rhead to chase.

# 10. To agree distribution of Housing Needs Survey

The Clerk advised the schedule for distribution, collection of responses and issuing of report as agreed with WRCC, and distribution of the survey by the Councillors was agreed.

# 11. To discuss issues within the Parish relating to highways (eg. the state of the roads, parking, overgrown hedges, etc)

Review of issues reported at the last meeting:

- Brittons Lane the fallen tree which had collapsed onto Brittons Lane was reported to County Highways and dealt with immediately.
- New Inn Hedge following completion of the sale of the New Inn, the hedge has now been cut back

#### New issues:

- It was noted that the ditch opposite Blacon Farm drive had been cleared out.
- The Clerk noted that there was a pot hole by the side of the gulley opposite windmill which is to be reported to county highways.

# 13.5 To consider a request from Norton Lindsey and Wolverton Cricket Club for a grant towards the cost of installing a two-lane outdoor practice cricket net on the Playing Field in Norton Lindsey

Cllr Neale and Cllr Mann declared an interest. Following the declarations of interest, the meeting was not quorate. It was agreed that the Clerk would send confirmation of receipt of the request, and that the Cricket Club should forward a revised request specifying the amount of grant it would like the Parish Council to make. Once this is received, it would be forwarded to all Councillors, and it was agreed that the Councillors who had not declared an interest would take a vote.

# 14. Planning Matters

# 14.1 To consider planning applications received:

Poultry Farm, Warwick Road – W/16/1970

Following the extraordinary meeting held on 9 January, the Parish Council considered the views that had been expressed by the parishioners and it was agreed that NLPC objects to this planning application on the following grounds:

- 1. The proposed development is in the greenbelt and falls outside the kind of infill development envisaged in the draft local plan;
- 2. It represents overdevelopment of the site an inappropriate dense cluster of houses some distance removed from the village proper;
- 3. NLPC has concerns about the volume of traffic onto the site, the potential parking issue along the road because the proposal has limited parking for visitors and service vehicles, and restricted access for service vehicles. In addition, NLPC would ask why the Highways Authority does not consider these issues to be of concern now when it

- had serious objections 9 years-ago when there was a planning application to restore poultry buildings;
- 4. There is no provision for pedestrian access onto the site or into the village, and the proposal is therefore totally car dependent.

# 14.2 To consider proposed planning applications outside Norton Lindsey Parish:

2 Curlieu Cottages, Curlieu Lane (Stratford District) – the applicant addressed the Council on the proposed planning application in SDC. NLPC was not able to comment as the application had not yet been submitted.
